PARK PROJECT UPDATE:

AZIEZ HASSAN present to the Board a copy of the contractions site plan of the park and address to the Board the copy will stay in the office for the community to come by and see the plan whenever they like.

ENGINGEER MATTERS:

A. USDA Well Replacement Project:

- a. Well Drilling Status
 - 1. It was reported to the Board that on December 16, 2022, USDA indicated that the Bid Documents for the West Well Project are acceptable for Bidding purposes;
 - 2. A Pre-Bid Meeting will be conducted at District Office and work site on Tuesday, January 17, 2023, at 2pm;
 - 3. The Bid opening will occur at the Engineer's Office on Tuesday, January 24, 2023, at 10 am;
 - 4. Tree Removal at Well Site. See motion and action in #5; and
 - 5. Greenleaf Farms Lease agreement amendment. By motion of Director Gloria De La Torre, seconded by Director Anna Domingo and carried by a vote of 4 to 0, it was determined amend the lease agreement with Greenleaf Farms to add the removal of the well site trees at an estimated cost of \$14,120, to reduce the rent by the amount of acreage set aside for the well site, approximately 0.49 acres and direct County Counsel to prepare a lease agreement amendment;

b. Annual Financial Audits and USDA Letter of Conditions.

According to the USDA Letter of Conditions for current USDA funding, the District will need to bring their audited financial statements up to date within one year after loan closing.

B. American Rescue Plan Act (ARPA):

Staff will contact the County regarding the status of the ARPA funding agreement.

C. Nitrate Control Program:

Engineer Blair indicated no new updates were available.

OPERATOR REPORTS:

• The District Operator reported no issues with the operation of the Water and Sewer systems.

• The Middle Well January, 2023, Standing Water Level (SWL) was 148 feet below ground surface and the Pumping Water Level (PWL) was 153 feet below ground surface. In comparison, the January, 2019, SWL was 143 feet and the January, 2017 SWL was 170 feet, both below ground surface.
