Water and sewer system have been operational without any issues. Test results have came back within discharge and sample requirements. Well depths as of 12/28/23 were recorded at 101ft. at the North Well and 101ft. at the Middle Well. These numbers are indicators that the well depths are rising. Minor repairs were made at the following location on the date listed. On 12/15/23 at 14572 rd. 190 a service line repair was conducted upon replacement of the service line it was determined that the damage was due to normal wear and tear. Also water sample collection sites located on Tobias Rd. and Ave. 144 have been determined to need replacement. The following is a request for purchase for a laser well sounder which is used for monitoring well depths. The current well sounder is the reel type which has a tendency to become snagged in the casing and becomes extremely difficult to remove. Extraction of the probe (which measures well depth) usually results in loss of the probe which is attached to the reel. Purchase of a new sounder will eliminate the reoccurring cost of replacement for the current sounder. I have attached a overview of the cost for the requested new equipment.
