8. OPERATOR REPORT:

The operator report for the month of December 2024 is as follows. The Poplar wastewater treatment plant was fully operational without interruption while the Poplar water treatment facilities experienced intermiten inturruption on 12/20/24. The interruption was determined to be a loss of power which was due to a damaged SoCal Edison facility (power pole). The water system was monitired closely and without further issues until power was restored to facilities. Multiple calls for service were placed on the following dates at the following locations. On 12/2/24 @14423 Rd.193(customer resp), 12/16/24 @14781 Rd.192(District resp) and on 12/18/24 @ 14691 Kilroy Ave. (District resp). All calls were resolved without further incident. All lab results have came back within discharge requirements and the well depths are as follows North Well @ 101 ft. and Middle Well @ 107 ft. This concludes the operator report for the month of December 2024.

The operator report for the month of January 2025 is as follows. The Poplar wastewater treatment plant was fully operational without interruption while the Poplar water treatment facility

experienced intermiten interruption on 1/9/2025 and 1/15/2025. The the loss of power on the 9th was due to a damaged SoCal Edison facility (power pole) while the power loss on the 15th was determined to be intermiten power outage. In addition a fire hydrant located at 14417 Rd 192 was observed to be damaged (struck by vehicle) the hyrant was flagged to indicate that it is non-operational and means of restoring functionality are being reviewed. A call for service was placed on 1/13/2025 @14621 Rd 192 which was determined to be district responsibility. The issue was resolved without further incident. All test results have come back within discharge requirements and the well depth are as follows, on 1/28/2025 North Well @99ft, Middle Well @110ft. This concludes the operator report for the month of January 2025.
